

## Marta Miączyńska (IIMCB) and Anders H. Lund (BRIC) appointed new Chair and Co-Chair of EU-LIFE

**Marta Miączyńska**, Director of the International Institute of Molecular and Cell Biology in Warsaw ([IIMCB](#)), and **Anders H. Lund**, Director of the Biotech Research & Innovation Centre ([BRIC](#)) at the University of Copenhagen, have been appointed the new Chair and Co-Chair of EU-LIFE, the alliance of independent research institutes in the life sciences across Europe, as of 1 January 2026.

Over the next two years, Marta and Anders will work closely with **Marta Agostinho**, EU-LIFE's Executive Director, to help steer the alliance's scientific and policy agenda at a crucial time for European research.
